📠 COMMUNICATION UPDATE: BRIGHTWHEEL REQUIRED

In compliance with Senate Bill 181, all communication between families and staff must now take place through the Brightwheel app.

This ensures transparency, safety, and proper documentation for all conversations.

If you haven't downloaded the app yet, please do so and let us know if you need help getting started.

📖 NEW SECURITY MEASURES AT THE FRONT DESK

To enhance security and ensure efficient access to the building, we're installing a doorbell with visual access to the reception area on the interior lobby door that leads to classrooms.

We want to be clear:

- You are still welcome to drop off and pick up your child from their classroom.
- The doorbell is simply an added precaution to control access and ensure the safety of everyone in the building.
- Occasionally, staff may not be at the reception desk because we are actively supporting classrooms. If this happens, just ring the bell—we'll be with you as quickly as possible!

Thank you for your patience and understanding as we implement this helpful safety feature.

📄 CCAP SUBSIDY CO-PAYS

For families who qualify for the Childcare Subsidy, we waited for the paperwork to be processed before setting up a copayment plan for the amount that CHFS notified you that you would be responsible for (if any). Invoices for current balances will be issued before June 24th. Starting the following Friday, June 27th, you will receive regular weekly invoices if your co-pay exceeds the subsidized amount. Please reach out to us if you have any concerns about your balance or need to make adjustments to your plan's due date. We understand that some families have not yet completed the process, and we will create a plan as soon as we receive your final approval.

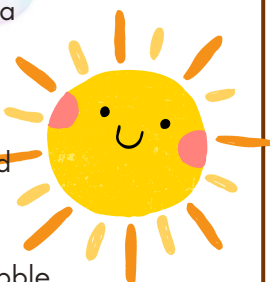


YOU DON'T WANT TO "MISS" IT SUMMER CELEBRATION!
